1. We have reviewed the accompanying statement of unaudited financial results of Genesis IBRC India Limited (Formerly, 'SSK Lifestyles Limited') (the "Company") for the quarter and Nine months ended 31st December 2025 (the "Statement") attached herewith, being submitted by the company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
